Important: A member company’s wholly owned divisions or subsidiaries may be included under the principal company’s membership providing that the individual wholly owned divisions or subsidiaries total gross global rail sales/service revenue is considered when determining 2019 RSI dues. RSI dues are not prorated and last one calendar year (January – December).

RSI is a not-for-profit incorporated trade association under S501 (c) of the Internal Revenue Code. Hence, dues are not deductible as a charitable contribution; but the percentage of your dues not allocated to federal and state lobbying is deductible as a normal business expense. Thirty (30%) percent of dues is allocated to lobbying activities.
