PROVIDING RESOURCES AND INFORMATION

The RSI provides industry research, data and resources that inform our members, government agencies and legislators about the collective contributions of our industry in the areas of safety, sustainability and economic growth as well as the impact of proposed rules and legislation on rail suppliers in North America. RSI is a credible and trusted source of information that informs decision-makers and the media.

CREATING REAL RELATIONSHIPS BASED ON MUTUAL RESPECT AND TRUST

The RSI staff maintain strong relationships with legislators on Capitol Hill, with key regulatory agencies and other trade associations who advocate in the rail transportation space. In addition, the RSI assists its members in developing and maintaining their own relationships with their elected officials.

CONNECTING THE DOTS BETWEEN RAIL SUPPLY AND U.S. JOBS

Working with Oxford economics, the RSI unites all facets of the rail supply industry to produce a comprehensive economic impact report that highlights both state and federal industry contributions to jobs, labor income, taxes and GDP. This report is widely sourced and used in both the RSI staff and member lobbying efforts.

SHOWCASING OUR TECHNOLOGY

RSI members develop and regularly invest in new technologies that make the rail system safer, greener and more efficient. Each year, the RSI hosts Innovation in Rail Day on Capitol Hill to allow the industry to showcase the newest innovations to members of Congress and regulatory staff.



Our Technical Committees

RSI's technical committees bring together industry experts to collect data, address regulatory issues and collaborate on issues impacting various sectors of the rail supply industry.

American Railcar Institute (ARCI)

Tabulates and reports North American freight car data, works in coordination with the Association of American Railroads (AAR) on freight car design standards and represents specific interests of railcar builders in federal legislative and regulatory matters.

Committee on Tank Cars (CTC)

Remains at the forefront of the latest research to improve tank car safety; collaborates with the AAR Tank Car Committee to review tank car requirements and represents tank car manufacturers in federal, legislative, and regulatory matters.

Standard Coupler Manufacturers Committee

Promotes AAR standard coupler technology worldwide and deals with technical matters affecting the use of that technology.

Quality Assurance Committee (QAC)

Develops industry best practices, documents, and guidelines to improve supplier products, processes, and services.

Equipment Leasing Committee (ELC)

Monitors and engages on key regulatory and policy issues affecting the freight railcar leasing industry.

State Taxation Committee

Proactively monitors and engages with state legislatures to provide input on issues that affect the taxation of freight railcar owners and lessors.


RSI's technical committees provide a premier opportunity for freight railcar owners and leasing companies like ours to engage with regulators and the AAR on issues that impact our business.



ARCI

The RSI ARCI is the only organization that tabulates and publishes proprietary freight railcar statistics. This information includes statistics on open top hoppers (steel, aluminum), flat cars (non-intermodal, intermodal), tank cars, and more.

Tank Car Resource Center

The RSI CTC pushes forward to improve railcar safety and publishes data and relevant information on the Tank Car Resource Center, a one stop shop for regulators, legislators, and the media to learn more and inform their decisions.
